**Call to Order/Roll Call** ~ Supervisor Pat Murphy called the meeting to order at 5:00 pm. **Approval of Prior Meeting's Minutes** ~ A motion was made by Trustee Robertson to accept the minutes from the last regular board meeting on February 9<sup>th</sup> 2010. The motion was 2<sup>nd</sup> by Trustee Zeien and passed with Trustees Carlson, Robertson, Zeien, Turner and Supervisor Murphy indicating aye on a voice vote.

**Supervisors Report** ~ no report at this time.

**Highway Commissioner's Report** ~ Hwy Commissioner Lee received a bill from the State after four years for the lights at Hwy 76 & Squaw Prairie Road in the amount of \$7,900 this is after costs, the original contract price was \$6,900 signed in 2006. The bill is due March 4<sup>th</sup> but will be paid late because we don't have another Board meeting until March 9<sup>th</sup>. Rich is working on his road projects for this spring with the County Engineer to get a ball park figure on what it's going to cost

**Assessor's Report** ~ Assessor Helnore handed out a summary of her offices activities and stated that there will be a Proval training class on June 10<sup>th</sup> & 11<sup>th</sup> at the Belvidere South Middle School for the assessors. John Elder has input the BOR adjusted values into the commercial/industrial spreadsheet and into Proval. A pie chart was also handed out to the Board Members showing how your property tax dollars are distributed and another pie chart showing the 2009 Board of Review findings. The Assessors web site is still under construction and should be finished soon.
