Call to Order/Roll Call ~ Supervisor Bernard O'Malley called the meeting to order at 5:00 pm. The pledges to the Flag were said and roll call taken with the following Board Members present Trustees Turner, Snow, Nelson and Supervisor O'Malley, also present Assessor St. Angel, Clerk Dixon and Hwy Commissioner Dixon. We have a quorum to do business.

Discussion and Potential Action on Approval of Prior Meeting's Minutes ~ A motion was made by Trustee Snow to approve the minutes from the last regular township board meeting on March 24, 2026. The motion was 2nd by Trustee Nelson and passed with Trustees Nelson, Turner, Snow and Supervisor O'Malley indicating aye on a voice vote.

Supervisors Report ~ Got the building permit and are working on the roof. We still have two air conditioning units to install. Our CD's are earning about 3.8% for a shorter term. We got our tax rate and both the township and road district are both lower. We have a fund application that will be on the next agenda. Still no news on the elevator. They have until this Fall to complete the work.

Highway Commissioner's Report ~ Got all the snowplows and spreaders off the trucks and are getting the trucks tested. One plow and wing is getting sandblasted & re-painted. Contracted a culvert liner company to line two culverts on Olson Road by Rellswood subdivision to prolong the life of these very deep and expensive to replace culverts.

Assessor's Report ~ Working on re-valuations. Residential deputy assessors have been doing field work. Had our first training session with the new Ames appraisal software.

Clerk's Report ~ Thank you all for filing your Economic Interest Statements with the County Clerk's office.

Trustee's Report ~ **Trustee Nelson**, (Community Building Complex) Next meeting is April 16th. **Trustee Snow**, (Growth Dimensions & City Council/County Board Liaison) Growth Dimensions executive meeting is 4/15 and regular meeting is next month. **Trustee Turner**, (Building Maintenance & Senior Trustee Duties) Nothing at this time.
